

An Autumn Ride in West Virginia

On October 16, 24 of us piled into two vans at 8 am, just as it started to rain. The rain did not dampen the spirits in the vans as we traveled to and from Elkins, West Virginia. The fun continued as we boarded the New Tygart Flyer for a 4-hour train ride, heading south along Shavers Fork River, then returning, with a stop at Cheat Falls, a beautiful waterfall. We also crossed the Eastern Continental Divide (elevation 3,900). Comfortable and cheery, the ride included a sandwich buffet, lots of good views, and great fellowship in our train car! By the time we got back to Harrisonburg the sun was out again, and everyone agreed it was a great trip. We have more day trips being planned for the future; stay tuned.



















Planning as We Age

Sarah M. Morton, Elderly Services Attorney for Blue Ridge Legal Services Harrisonburg office, spoke with 21 VV members and guests on Oct. 10 about financial, medical and funeral planning in later life. Her topics and recommendations included:

- Appointment of an adult guardian (best to avoid a court having to do this);
- Setting up deposit and automatic bill payments (an "auto debit" is less safe);
- Third-party notification (a procedure for your creditor notifying someone in your family if you miss a payment);
- Power of attorney (i.e. "attorney in fact," giving someone power to act in your place for legal and financial matters. Only a "durable power of attorney" remains in effect if you become incapacitated);
- Advance Medical Directive, a.k.a. "living will": Anyone over aged 18 should complete such a document, giving their wishes in case of incapacitation and specifying who should make decisions in that case.
- Funeral planning: Assigning the person who will manage funeral arrangements, plus a back-up, is recommended. If a body is donated to medical research, it will later be cremated and ashes returned to the family. A new option of a "green burial" uses a biodegradable casket and does not require embalming. Rituals such as washing the body are making a comeback.



- Will: Preparing a will is necessary. A "holograph" will requires approval, after death, by two persons familiar with the deceased's handwriting. Sarah advised that no lawyer is required for preparing a will but that hiring a lawyer is highly recommended, as for most other procedures she described.
- Scams: Sarah described some types of scams used to prey on elderly people. BRLS has represented many such victims, often cheated by those who preyed on their loneliness or trusting nature.

Palliative Care and End-of-Life Doulas

On Nov. 7, Rene Hostetter talked with Valley Village about the End-of-Life Doula program, an aspect of Sentara RMH's palliative care program. Palliative care is an approach that improves the quality



of life of patients and their families who are facing the challenges of life-threatening illness. An End-of Life (EOL) Doula, also known as a death doula, provides comfort and support to a dying person and his or her loved ones.



End-of-Life (EOL) Doulas are non-medical people trained to share resource information, education and companionship with those nearing the end of life. The term doula has long been used to describe a lay person trained to assist and comfort a mother before, during, and after childbirth. As a birth doula helps usher a child into the world, an end-of-life (EOL) doula helps usher individuals out of the world. Rene Hostetter has served as a Palliative Care Chaplain with Sentara RMH for over three years, and End of Life Doula through INELDA (International End of Life Doula Association), and serves as a spiritual director in the program.



December 20, 2019 - "Miracle on 34th Street"

In this original 1947 Christmas classic, drama ensues for Kris Kringle, (Edmund Gwenn), Natalie Wood (a small girl), and Maureen O'Hara (her mother), when Mr. Kringle, portraying Santa in the Macy's parade, announces he's the real one.

Jan. 17, 2020 - "West Side Story"

1961 film of the classic musical scored by Leonard Bernstein. Maria and Tony fall in love, but (as it was for Romeo and Juliet) find their love shadowed by a feud – this time between rival gangs on Manhattan's West Side.

Feb. 21, 2020 - "Seabiscuit"

A jockey (Tobey Maguire), an automobile magnate (Jeff Bridges) and a trainer (Chris Cooper) – none of whose futures look promising – lead a racehorse (one that draws almost no bets) to glory during the Great Depression.

Mar. 20, 2020 - "Because of Winn-Dixie"

As in Kate DiCamillo's children's book, a Florida girl (AnnaSophia Robb) and her canine pal (named for a store where he's caught running amok) restore hope for her lonely preacher father (Jeff Daniels) – aided by a shy ex-con storekeeper (Dave Matthews) and wise elder woman (Cicely Tyson).

Apr. 17, 2020 - "Before the Flood"

This 2016 film, narrated by Leonardo DiCaprio, takes us around the world to view effects of climate change on our environment and what might be done to prevent loss of endangered species, ecosystems and native communities.

May 15, 2020 - "Gorillas in the Mist"

The 1988 film tells the true story of anthropologist Dian Fossey (Sigourney Weaver), who defended the mountain gorilla from poachers in Rwanda and, despite obstruction and tragedy, helped save them from extinction.
