It was evident that most of those in the circle were tired of their home confines and glad to meet, at a safe distance from each other. The size of the group could be adjusted based on space available. If safety distancing may no longer be an issue, Supper Club members may want to each simply bring a dish to share.

Nancy Jiunta Shomo, GC-C, is scheduled to present a talk on "Loss and Depression" Aug. 13. She is Coordinator of Bereavement Services with SRMH Behavioral Health and a credentialed grief counselor certified in CISM (Critical Incident Stress Management) and Perinatal Loss Counseling.

Nancy, a certified healthcare professional in perinatal loss, has worked with families for over 40 years and trains healthcare professionals in this field.

She specializes in helping individuals and families cope with the difficulties and pain associated with loss and grief by providing education, individual and family consultations, educational workshops/ presentations and trainings. She also provides education and support for area businesses, schools, universities and retirement communities.

The NPR podcast, Social Distance Assistance, recently featured Nancy on their July program. She addressed the impact of COVID 19 on emotional health and the grieving process.

## Valley Village Tour Outings, Aug – Dec 2020

\*Saturday, Sept 26, 7:00 p.m., American Shakespeare Center Performance, Staunton Join Valley Village friends for an outdoor American Shakespeare Center performance of Twelfth Night at Blackburn Inn, 301 Greenville Ave, Staunton. Due to COVID, registrants will provide their own transportation and chairs, and seating will be socially distant according to households, or as requested.

If inclement weather, the performance will be indoors at Blackfriars Playhouse, 10 S Market Street, Staunton. If held indoors, participant masks are required and social distancing by households will be practiced.

For audience safety, performers will be self-isolating 2 weeks prior and during the performance season. Cost is \$20/person.

\*Mon, Oct 12, 12:00 – 3:00 p.m., Skyline Drive Adventure with Picnic and Optional Hike

Meet at Pinnacles Picnic Area around milepost 36 at 12 noon for lunch. Bring your own lunch and lawn chairs if desired. Plan about an hour and a half to get there from Harrisonburg whether you come by way of Rt 33 and go north on Skyline Drive or go past Luray on Rt 211 and go south on Skyline Drive. Don't forget you will need a National Parks pass to get on the drive or pay admission fee upon entrance.

After lunch we will travel 7 miles south to the Limberlost Trail at about 1:30 pm (about mile 43) for a hike on an easily accessible trail. Completing the circle is a mile and a third, but you can turn back any time, and there are lots of benches

to rest on. The trail is wide enough that you can meet other people and allow safe distancing as you pass. See the picture of the trail and deer from a previous hike there.

This outing can be done by leaving Harrisonburg about 10:30 am and arriving back about 4 pm, but this is a great opportunity to take extra time and enjoy a leisurely drive on Skyline Drive!

Paul's and Keith's work eventually led to our finding Boston's Beacon Hill, the founding chapter of the "Village" movement, with the mission of supporting people choosing to remain at their homes as long as possible.

#### Valley Village welcomes two new board members:

**ANN BENDER** served as Executive Director of Valley Program for Aging Services, the area agency on aging for the Central Shenandoah Valley, for 19 years. Prior to that she was Director of the Broadway-Timberville Senior Center and the Apple Tree Craft Shop for the agency. She served as president of the Virginia Association of Area Agencies on Aging for two years and was secretary for the Virginia Coalition for the Aging prior to that.

After retirement in 2001, she taught a course in the Gerontology Series in the Social Work Department at JMU for 7 years.
